The domain for experienced social workers states:


DIVERSITY AND EQUALITY - Recognise diversity and apply anti-discriminatory and anti-oppressive principles in practice

I inform, guide and model good practice in the application of understanding of identity, diversity and equality to practice

I model critically reflective practice and support others to recognise and challenge discrimination, identifying and taking professional action

I act (individually or collectively) to challenge breaches and limitations in the ability of my own or others' organisations to advance equality and diversity and comply with the law

I demonstrate and model the effective and positive use of power and authority, whilst recognising and providing guidance to others to avoid oppressive practice.³

Programme Overview



Strengthening Partnerships Programme (SPP)

This programme is for all practitioners working directly or indirectly with children, young people, and families. This includes adult services who work with parents and carers to help them understand the role they should play and the role of other practitioners.

Its overall aim is to strengthen and promote partnership working, develop learning and professional practice and thereby improve outcomes for children and young people.

We have taken what we know is helpful and works and developed a programme that speaks to current issues and theories informed by practice; this includes experts by experience and subject experts. Our programmes are supported by a wealth of learning strategies, materials and tools to support practice.

Training and practice improvement is the principal focus of Strengthening Practice. We design and provide customised training programmes guiding staff through legislative and conceptual frameworks in order to understand how this knowledge applies to the context of their organisation; their local policies and procedures; and the children, young people and families they support. "Cross-agency training was a success in building relationships across agencies." ⁴

Key to this programme is the learning and proposals recommended by The Child Safeguarding Review Panel following the tragic deaths of Arthur Labinjo-Hughes and Star Hobson in 2021.

"Despite the intentions of recent reforms... multiagency safeguarding arrangements are not yet fit for purpose everywhere. This results too often in blurred strategic and operational responsibilities, creating fault lines in practice arrangements. This has major consequences for the ability of practitioners across different agencies to work together skilfully and purposively to protect children" ⁵
